INDIVIDUAL BILLING

Purchases such as air, hotel and or car hire are nominated to be paid directly by the company. Simultaneously, these same purchases will be visible on the Cardmembers statement however their total will not form part of the balance – that total will be sent on a separate statement to the company for direct settlement with Diners Club.
